Akamai Technologies, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

**FIRST:** That the Corporation was incorporated on the 20<sup>th</sup> day of August, 1998, pursuant to the General Corporation Law of the State of Delaware.

**SECOND:** That the Corporation owns all of the outstanding shares of each class of the stock of Soasta, Inc., a corporation incorporated on the 26th day of January, 2006 pursuant to the General Corporation Law of the State of Delaware ("Soasta").

**THIRD:** That the Board of Directors of the Corporation, at a meeting duly held on the 12th day of December, 2017, duly adopted the following resolutions:

**FURTHER**

**RESOLVED:** That the President, Treasurer and Secretary of the Corporation be and each hereby is, authorized to execute a Certificate of Ownership and Merger with respect to the merger of Soasta into the Corporation, cause the same to be filed with the Secretary of State of Delaware and take all such other actions and to execute all such other instruments and agreements as they or any of them may deem appropriate to effect such merger.

**FURTHER**

**RESOLVED:** That the proper officers of the Corporation and each of them acting singly be, and hereby are, authorized and directed to take such actions as may be necessary or advisable to carry out the

foregoing resolutions, including without limitation executing agreements and plans of merger and making filings with appropriate state governmental authorities.

**FOURTH:** That the merger shall become effective on December 31, 2017.
