ASSIGNMENT OF INTELLECTUAL PROPERTY

This ASSIGNMENT OF INTELLECTUAL PROPERTY (this “Assignment”), dated March 2, 2020, is entered into by and between Camelot Newspaper Buyer, LLC, a Delaware limited liability company (“Assignor”), and Cox Enterprises, Inc., a Delaware corporation (“CEI”) and Ohio Newspapers, Inc. (“Assignee”).

WHEREAS, this Assignment is made pursuant to that certain Asset Purchase Agreement dated February 8, 2020 by and between Assignor, Assignee, and, solely for purposes of Section 8.10 thereunder, Terrier Media Buyer, Inc., a Delaware corporation (as amended, modified or supplemented from time to time, the “Purchase Agreement”);

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to, among other things, sell, transfer, convey, assign and deliver to Assignee all of its right, title and interest in, to and under the Intellectual Property included within the Dayton Newspaper Assets, including, but not limited to, the Intellectual Property set forth on Exhibit A attached hereto (the “Dayton IP”) free and clear of all Liens, other than Permitted Liens, and Assignee has agreed to accept such assignment; and

WHEREAS, pursuant to that certain Assignment and Assumption Agreement, dated March 1, 2020, by and between CEI and Assignee (the “Assignment Agreement”), CEI assigned all its right, interest and obligation under the Purchase Agreement to Assignee (including the right to directly purchase the Dayton Newspaper Assets pursuant to the terms of the Purchase Agreement, subject to the term and conditions thereunder).

NOW, THEREFORE, pursuant to the terms and conditions of the Purchase Agreement and in consideration of the mutual covenants and agreements contained therein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Defined Terms. Capitalized terms used but not defined in this Assignment shall have the meanings set forth in the Purchase Agreement.

2. Assignment of Dayton IP. Assignor hereby irrevocably sells, transfers, conveys, assigns and delivers to the Assignee (i) all of its right, title and interest in and to the Dayton IP, whether statutory or at common law, including all registrations and applications therefor, (ii) the right to sue and recover for all past, present and future infringements and other violations of such Dayton IP (including, without limitation, the right to receive all monies, proceeds, settlements and recoveries in connection therewith), (iii) the goodwill associated with such Dayton IP in the operation of the Business, the same to be held and enjoyed by Assignee to the same extent that such would have been held and enjoyed by Assignor had this assignment not been made, free and clear of all Liens, other than Permitted Liens, and (iv) all other rights of any kind whatsoever of Assignor accruing thereunder or pertaining thereto, and Assignee hereby accepts the assignment of such Dayton IP.

3. Acknowledgment. Assignor hereby acknowledges that from and after the date hereof, Assignee shall be the exclusive owner of all of Assignor’s right, title and interest in and to the Dayton IP.

4. Purchase Agreement. This Assignment is intended to evidence the consummation of the transactions contemplated by the Purchase Agreement and is subject to the terms and conditions set forth in the Purchase Agreement. This Assignment is made without representation or warranty, except as provided in and by the Purchase Agreement. Notwithstanding anything to the contrary herein, nothing contained in this Assignment shall be construed to supersede, limit, restrict, expand, enlarge, modify or qualify in any manner the rights and obligations (including without limitation any liability) of the parties under the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern.

5. Further Assurances. At any time after the date hereof, each party shall from time to time, at the request of and without further cost or expense to the other, execute, acknowledge and deliver such other further assignments, conveyances, and other assurances, documents, and instruments of transfer reasonably requested by the other party, and take such other actions consistent with the terms of this Assignment as may reasonably be requested in order to assign, transfer, grant, convey, and confirm to Assignee the Dayton IP or otherwise consummate the Transactions. To the fullest extent permitted by applicable Law, Assignor hereby authorizes Assignee and gives Assignee its irrevocable power of attorney, with full power of substitution, which authorization shall be coupled with an interest, to take any and all steps in Assignor's name and on behalf of Assignor that are necessary or desirable in the reasonable determination of Assignee to assign, transfer, endorse, negotiate, deposit or otherwise realize on any Dayton IP or any writing of any kind in connection with any Dayton IP if Assignee does not do so within a reasonable period of time after receipt of a request from Assignee.

6. Governing Law; Consent to Jurisdiction. All disputes, claims (and counter-claims), controversies or causes of action (whether at law or in equity, whether in contract or in tort or otherwise) based upon, arising out of or relating to this Assignment, or the negotiation, validity or performance of this Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, without regard to its rules of conflict of laws. Each of Assignor and Assignee hereby irrevocably and unconditionally consents to submit to the sole and exclusive jurisdiction of the Delaware Court of Chancery; provided, that if (and only after) such court determines that it lacks subject matter jurisdiction over any particular matter, such matter shall be brought in the Chosen Courts, for any Action arising out of or relating to this Assignment or the negotiation, validity or performance of this Assignment (and agrees not to commence any Action relating thereto except in such Chosen Courts), waives any objection or defense with respect to the laying of venue of any such Action in the Chosen Courts and agrees not to plead or claim (or counter-claim), or advocate as a defense, in any Chosen Court that such Action brought therein (i) has been brought in any inconvenient forum, (ii) should be transferred or removed to any court other than one of the Chosen Courts, or (iii) should be stayed by reason of the pendency of some other proceeding in any court other than one of the Chosen Courts. Each party hereto hereby agrees not to commence any such Action other than before one of the Chosen Courts. Each party hereto agrees that a final, non-appealable judgment in any Action so brought shall be conclusive and may be enforced by suit on the judgment in any court of competent jurisdiction, or in any other manner provided by Law.

7. Successors and Assigns. No party hereto may assign this Assignment without the prior written consent of the other parties hereto. The terms of this Assignment shall bind and inure

to the benefit of the parties' respective successors and any permitted assigns, and no assignment shall relieve any party of any obligation or liability under this Assignment. Notwithstanding the foregoing, Assignee may assign any or all of its rights under this Assignment to any of its Affiliates or to its or its subsidiaries' lenders as collateral security without the consent of any of the other parties hereto, and no assignment shall relieve any party of any obligation or liability under this Assignment.

8. Counterparts. This Assignment may be executed in two or more counterparts, which together shall constitute a single agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile, .pdf or electronic mail intended to preserve the original graphic and pictorial appearance of the signature shall be effective as delivery of a manually executed original counterpart of this Assignment.

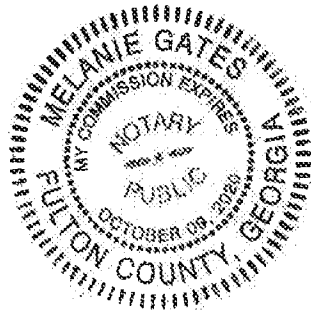
