Pursuant to Section 264 of the General Corporation Law of the State of Delaware

Sardel Inc., a Delaware corporation (the "**Company**") does hereby certify as follows:

FIRST. The name and domicile of each of the constituent entities in the merger are:

- a) Sardel Inc., a Delaware corporation; and
- b) RDA Kitchen LLC, a New York limited liability company ("**RDA Kitchen**").

SECOND. An Agreement and Plan of Merger, dated as of May 27, 2020 by and among the Company, RDA Kitchen, and the members of RDA Kitchen ("**Merger Agreement**"), setting forth the terms and conditions of the merger of RDA Kitchen with and into the Company (the "**Merger**"), has been approved, adopted, certified, executed, and acknowledged by each of the constituent entities pursuant to the General Corporation Law of the State of Delaware.

THIRD. The name of the surviving corporation in the Merger (the "**Surviving Corporation**") is Sardel Inc.

FOURTH. The Certificate of Incorporation of the Company, as it exists immediately prior to the time of effectiveness of this Certificate of Merger, and as is duly filed with the Secretary of State of the State of Delaware, shall be the Certificate of Incorporation of the Surviving Corporation and thereafter may be amended in accordance with its terms and as provided by law.

FIFTH. The executed Merger Agreement is on file at the principal place of business of the Surviving Corporation, which is located at 27 Evans Drive, Glen Head, New York, 11545.

SIXTH. A copy of the Merger Agreement shall be furnished by the Surviving Corporation, on request and without cost, to any member of RDA Kitchen or stockholder of the Company.
