From time to time after the date hereof, at the request of either Party hereto, and at the expense of the Party so requesting, each of the Parties hereto shall execute and deliver to such requesting Party such documents and take such other action as such requesting Party may reasonably request to consummate more effectively the transactions contemplated hereby.

ASSIGNOR hereby represents, warrants and covenants that it owns all right, title and interest in and to the Trademarks, that it has the full power and authority to convey all right, title, and interest in and to the Trademarks to ASSIGNEE, that it has not executed and will not execute any agreement in conflict herewith.


