The undersigned, Bradford C. Craig, hereby declares that:

1. He is attorney for Counsel Press Inc., the owner of the above-identified trademark and registration, and is authorized to execute this Declaration on behalf of said owner.

2. The assignment properly recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office at Reel/Frame 5975/0517 assigning the above-identified trademark from Dolan LLC ("Assignor") to Counsel Press Inc. ("Assignee") was executed and effective as of March 31, 2015.

3. Counsel Press Inc. was and continues to be the correct and accurate owner of the subject mark and registration therefor and has at all relevant times since the effective date of the assignment, March 31, 2015, been the exclusive owner of said mark and registration therefor.

4. On January 15, 2016, Dolan LLC and Dolan Media Holding Company recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office at Reel/Frame 5710/0566 an assignment of the above-identified trademark from Dolan LLC and Dolan Media Holding Company to New Media Holdings I, LLC ("Improper Assignment No. 1"). That assignment document was executed on December 31, 2015.

5. On November 2, 2016, New Media Holdings I, LLC recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office at Reel/Frame 5913/0070 an assignment of the above-identified trademark from New Media Holdings I, LLC, to Lawyer's Weekly, LLC ("Improper Assignment No. 2"). That assignment document was executed on January 1, 2016.

6. At the time of Improper Assignment No. 1, the assignors of Improper Assignment No. 1 did not own the above-identified trademark or registration therefor, as the entire interest and the goodwill had previously been assigned to Counsel Press Inc. as of March 31, 2015.

7. Therefore, the recordal of Improper Assignment No. 1 at Reel/Frame 5710/0566 was invalid and improperly filed with the Assignment Recordation Branch of the U.S. Patent and Trademark Office and should be removed from the record.

8. Similarly, at the time of Improper Assignment No. 2, the assignor of Improper Assignment No. 2 did not own the above-identified trademark or registration therefor, as the entire

interest and the goodwill had previously been assigned to Counsel Press Inc. on March 31, 2015.

9. Therefore, the recordal of Improper Assignment No. 2 at Reel/Frame 5913/0070 was also invalid and improperly filed with the Assignment Recordation Branch of the U.S. Patent and Trademark Office and should be removed from the record.

10. Counsel Press Inc., a Delaware corporation, was and continues to be the correct and accurate owner of the subject mark and registration therefor and has at all relevant times since March 31, 2015, been the exclusive owner of said mark.

11. As the true and correct owner of the above-identified trademark, Counsel Press Inc., having identified the errors in the improper assignment documents, requests correction of the same. See T.M.E.P. § 503.06(c).
