**Part 1: Trademark assignment**

TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is made on the 1st day of April 2020.

**BETWEEN**

Prism Entertainment, Inc., a California corporation with offices at 731A Emerson Street, Palo Alto, CA 94301 (the "Assignor").

**AND**

Ziggurat Interactive Inc., a Colorado corporation with office at 7424 S University Blvd, Unit #E, Centennial, CO 80122 (the "Assignee").

each a "Party", and together the "Parties", to this Agreement.

BACKGROUND

(A) The Assignor is the owner of the U.S. trademarks that are identified in Attachment 1, attached hereto, including the granted registration of the UPRISING mark in International Class 009 and the pending application for the KILLING TIME mark in International Class 009 (collectively, the "Trademarks").

(B) The Assignor has agreed to assign the Trademarks to the Assignee, and the Assignee has agreed to accept the assignment of the Trademarks, upon the terms and conditions of this Agreement.

In consideration of the sum paid (or to be paid) by the Assignee to the Assignor pursuant to the parties separate comprehensive Assignment Agreement, the sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. The Assignor hereby assigns and transfers to the Assignee all of the Assignor's rights, title and interests in and to the Trademarks (whether registered or unregistered), together with the whole of the goodwill in and to the use of the Trademarks and including, without limitation, any rights to take action against any past infringement or breach in relation to the Trademarks.

2. The Assignor shall, at the request, cost and expense of the Assignee, promptly take such actions (including, without limitation, the prompt execution and delivery of documents in recordable form or testifying as to any material fact of or concerning the Trademarks) as may be necessary to vest in, record and secure unto Assignee all of Assignor's rights, title and interests in and to the Trademarks and to protect and enforce the Trademarks.

3. The Parties agree that this Agreement shall be governed by the laws of the State of Colorado (excluding that body of law relating to choice of laws) and of the United States, and the parties hereby submit to the non-exclusive jurisdiction of the courts in the State of Colorado.
