**RESCISSION OF TERMINATION AND REINSTATEMENT OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS, FIESTA HOLDINGS, LLC ("Fiesta Grantor") along with Roma Foods, Inc., and Eateries, Inc. as Grantors entered into that certain Trademark Collateral Security Agreement dated as of December 29, 2006 (the "Security Agreement"), between such Grantors and Praesidian Capital Investors, LP ("Praesidian"), a true and correct copy of which was recorded by the United States Patent and Trademark Office on January 23, 2007, at Reel 3466 Frame 0463 with respect to the trademark registrations identified in Schedule A thereto;

WHEREAS, Practical Investors, LLC, an Oklahoma limited liability company ("Secured Party"), acquired from Praesidian all right and title under the Security Agreement as well as the underlying Secured Loan to Grantors;

WHEREAS, the Secured Loan and the Obligations of Fiesta Holdings LLC to Secured Party referenced in the Security Agreement are still owed and outstanding, while the Obligations of Eateries, Inc. and Roma Foods, Inc. to Secured Party are no longer owed or outstanding.

WHEREAS, although termination of the Security Agreement as it pertains to Fiesta Grantor was mistakenly included in that certain Termination of Security Interest in Trademark recorded by the United States Patent and Trademark Office on June 30, 2014, at Reel 005311 Frame 0852 the Security Agreement, insofar as the Security Agreement pertains to Fiesta Grantor, it is still in full force and effect.

WHEREAS, the Secured Party and the Fiesta Grantor desire to record the fact that the Security Agreement is still in full force and effect with respect to the Fiesta Grantor, and that any termination thereof is rescinded.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party and Fiesta Grantor hereby:

1. authorize and request the Commissioner of Patents and Trademarks of the United States of America to note and record the Security Agreement in the form recorded by the United States Patent and Trademark Office on January 23, 2007, at Reel 3466 Frame 0463 remains in full force and effect with respect to Fiesta Holdings, LLC and that Secured Party and Fiesta

Grantor rescind any termination thereof created by the Termination of Security Interest in Trademark recorded by the United States Patent and Trademark Office on June 30, 2014, at Reel 005311 Frame 0852.

2. Schedule A to the Security Agreement is hereby amended and restated in the form attached hereto as Revised Schedule A.
