DECLARATION TO CORRECT APPARENT OWNERSHIP

THIS DECLARATION TO CORRECT APPARENT OWNERSHIP ("*Declaration*") is made effective as of April 29 2020 by FW Murphy Production Controls, LLC, a corporation organized under the laws of the State of Oklahoma, having an address of 4646 S. Harvard Ave., Tulsa, OK 74135, on its own behalf and on behalf of Enovation Controls, LLC, a corporation organized under the laws of the State of Oklahoma, having an address of 5311 South 122nd E. Ave., Tulsa, OK 74146, which is the correct current owner of the trademarks and associated registrations identified on the appended Exhibit A (the "*Marks*").

I hereby declare that:

I am the President of FW Murphy Production Controls, LLC, formerly named Murphy Industries, LLC.

On September 18, 2014, Murphy Industries, LLC assigned ownership of the Marks to Enovation Controls, LLC, which is reflected in the USPTO records in an Assignment recorded at Reel/Frame 5365/0546 and elsewhere (the "*Controlling Assignment*").

Years later, Murphy Industries, LLC changed its name to its current name, FW Murphy Production Controls, LLC, and on March 9, 2018, a Change of Name document was recorded, reflecting that change of the name from Murphy Industries, LLC to FW Murphy Production Controls, LLC, which is of record at Reel/Frame 6288/0629 (the "*Unnecessary Recordation*"). The Unnecessary Recordation should not have been recorded in connection with the Marks, as it was not intended to legally transfer ownership of the Marks and, indeed, should not affect actual ownership because it reflected a change pertaining to Murphy Industries, LLC, which no longer

owned the Marks – neither at the time of the actual change of name nor at the time when the Unnecessary Recordation occurred. Despite the earlier Controlling Assignment, the Unnecessary Recordation nonetheless caused the USPTO website to incorrectly reflect FW Murphy Production Controls, LLC as the current owner of the Marks.

Summaries of the sequence of pertinent instrument recordations for each of the Marks is set forth in Exhibit B, appended hereto.


I declare that the correct owner of these Marks remains Enovation Controls, LLC, as reflected by the Controlling Assignment, despite the subsequent Unnecessary Recordation.

I hereby respectfully request that the USPTO update their database to reflect that the correct owner is Enovation Controls, LLC.

I hereby acknowledge that any willful false statement made in this declaration is punishable under 18 U.S.C. 1001 by fine or imprisonment of not more than five (5) years, or both.

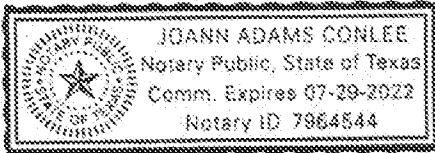
