ASSIGNOR hereby binds itself to properly execute without further compensation any and all applications, petitions, oaths, assignments or other papers and instruments which may be necessary to carry into full force and effect the interests hereby assigned or intended to be assigned; and ASSIGNOR further covenants that it has the legal right to convey the entire rights, titles and interests hereby assigned or intended to be assigned.


