## NUNC PRO TUNC TRADEMARK ASSIGNMENT

**THIS NUNC PRO TUNC TRADEMARK ASSIGNMENT (“Assignment”)** is entered into by and between **TRIBUNE BROADCASTING COMPANY II, LLC**, a Delaware limited liability company (“**Assignor**”), and **CAPE PUBLICATIONS, INC.**, a Delaware corporation (“**Assignee**”) (Assignor and Assignee are collectively the “**Parties**”).

**WHEREAS**, Tribune Broadcasting Fort Smith, LLC (“**Tribune Broadcasting Fort Smith**”) was the owner of the trademark set forth in Schedule A hereto, including any and all common law rights thereto (collectively the “**Trademark**”);

**WHEREAS**, pursuant to that certain Agreement and Plan of Merger, dated as of December 31, 2019, by and between Tribune Broadcasting Fort Smith and Assignor, Tribune Broadcasting Fort Smith merged with and into Assignor with Assignor continuing as the surviving entity;

**WHEREAS**, pursuant to a certain asset purchase agreement, Assignor assigned, and Assignee acquired, any and all rights, title and interest in the Trademark, effective as of September 19, 2019 (the “**Closing Date**”); and

**WHEREAS**, the Parties wish to separately memorialize the assignment of the Trademark to Assignee in this Assignment for clarity and recordation with the United States Patent and Trademark Office.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby irrevocably assigns, transfers, and conveys *nunc pro tunc*, as of the Closing Date, to Assignee, and Assignee hereby accepts from the Assignor, all of Assignor’s right, title and interest in and to the Trademark in the United States and throughout the world, all rights appurtenant thereto, together with the goodwill associated with said Trademark, as well as all of Assignor’s rights to sue for, recover from and receive all damages, at Assignee’s discretion, occurring from infringing or misappropriating uses of the Trademark by any third-party after the Closing Date.

This Assignment may be executed in two or more counterparts and shall be enforceable upon the exchange of executed counterparts by fax or e-mail. The separately executed copies shall each be deemed an original but all of which together shall constitute one and the same instrument and be binding on the Parties.


