## TRADEMARK ASSIGNMENT AGREEMENT



- (2) All income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation third party payments for past or future infringements and misappropriations of the Mark; and
- (3) All rights to sue for past, present and future infringements or misappropriations of the Mark.
