I, John Ruggiero, hereby attest:

1. I am a current Board Member of Innovation Associates, Inc. (hereinafter the "Company") and have been since 1/1/2003

2. A Unit Purchase Agreement was executed by and between the Company and each of the purchasers listed on Schedule I thereto dated September 13, 1999 (the Unit Purchase Agreement is referred to hereinafter as the "UPA", and the purchasers listed on Schedule I are collectively referred to hereinafter as the "Purchasers").

3. The UPA granted a security interest to the Purchasers in the Company's assets, including its intellectual property.

4. The Company and the Purchasers also entered into an Intellectual Property Security Agreement dated September 13, 1999 (hereinafter the "IP Security Agreement"). The IP Security Agreement granted to the Purchasers a security interest in all of the Company's intellectual property (including without limitation those Copyrights listed on Exhibit A to the IP Security Agreement, those Patents listed on Exhibit B to the IP Security Agreement, and those Trademarks listed on Exhibit C to the IP Security Agreement). The security interests granted in the IP Security Agreement serve as collateral for the prompt and complete repayment when due of the Company's obligations under the UPA.

5. The IP Security Agreement was recorded with the United States Patent and Trademark Office at reel/frame nos. 010226/0954-010226/0961 and 001960/0105-001960/0112.

6. In my role as Board Member of the Company, I represent the interests of those Purchasers who currently hold equity in the Company.

7. I attest that the Company has, in fact, satisfied each and every obligation under the UPA to each of the Purchasers, including by repayment of any debt or conversion of debt to equity in the Company.

8. With the obligations of the UPA fully satisfied, the security interests granted in the UPA and the IP Security Agreement are released and the Purchasers no longer hold any right, title, or interest in the Company's intellectual property.

9. I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true.
