RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated June 12, 2020 by Wells Fargo Bank, National Association, a national banking association (“WFB”), with its mailing address at 300 Barr Harbor Drive, Suite 850, Conshohocken, Pennsylvania 19428, acting as administrative agent for and representative of the Beneficiaries as defined in the Grant of Trademark Security Interest referred to below (WFB acting as such administrative agent being hereinafter referred to as the “Secured Party”);

WITNESSETH:

WHEREAS, Wanchese Fish Company, Inc., a North Carolina corporation (“Grantor”), with its principal place of business and mailing address at 48 Water Street, Hampton, Virginia 23663, and Secured Party are parties to a certain Grant of Trademark Security Interest dated June 5, 2015 between which was recorded in the United States Patent and Trademark Office on June 9, 2015 at Reel 5548, Frame 0812 (the “Agreement”), pursuant to which Grantor granted to Secured Party, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “Trademark Property”); and



(ii) All proceeds of the foregoing, including without limitation (x) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing and (y) any and all claims and causes of action by Grantor against third parties for damages, restitution and injunctive and other legal and equitable relief by reason of past, present or future infringement, dilution, misappropriation, violation, misuse, breach or default of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right but no obligation to sue for and collect, or otherwise recover, said damages.
