NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”), dated as of December 23, 2019, is made by **BANK OF AMERICA, N.A.**, as Administrative Agent with offices located at 901 Main Street, TX1-492-14-06, Dallas, Texas 75202 (the “**Administrative Agent**”), in favor of **JERSEY MIKE’S FRANCHISE SYSTEMS, INC.**, a New Jersey corporation with offices located at 2251 Landmark Place, Manasquan, New Jersey 08736 (“**Grantor**”).

W I T N E S S E T H:

WHEREAS, the Grantor and the Administrative Agent are parties to that certain Security and Pledge Agreement, dated as of December 18, 2015 (as amended, extended, restated, amended and restated, renewed, replaced, supplemented or otherwise modified from time to time, the “**Agreement**”), pursuant to which the Grantor delivered to the Administrative Agent (a) a Notice of Grant of Security Interest in Trademarks, dated December 18, 2015 (the “**2015 Notice**”) and (b) a Notice of Grant of Security Interest in Trademarks dated October 11, 2019 (the “**2019 Notice**” and together with the 2015 Notice, the “**Notices**”), each for recordation with the United States Patent and Trademark Office (the “**USPTO**”);

WHEREAS, pursuant to the Agreement, the Grantor granted a continuing security interest in, continuing lien upon and a right to set off against, among other things, any and all right, title and interest of the Grantor in and to all Trademarks of the Grantor, whether then owned or existing or owned, acquired or arising thereafter, including those trademarks and trademark applications, including those set forth on Schedule I attached hereto (collectively, the “**Trademark Collateral**”) to the Administrative Agent for the benefit of the Secured Parties;

WHEREAS, the 2015 Notice was recorded with USPTO on December 21, 2015 at Reel 5693 / Frame 0224, and the 2019 Notice was recorded with the USPTO on October 16, 2019 at Reel 6772 / Frame 0261;

WHEREAS, the Grantor desires that the Administrative Agent execute this Release in order to evidence the termination and release of its continuing security interest in, and right to set off against, the Trademark Collateral.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Agreement.

SECTION 2. Termination and Release. The Administrative Agent hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its continuing security interest, and right to set off against, any and all right, title and interest of the Grantor in and to the Trademark Collateral, and reassigns and transfers to the Grantor all right, title and interest that the Administrative Agent may have in, to or under the Trademark Collateral.

SECTION 3. Recordation. The Administrative Agent hereby authorizes the Grantor (or its designee), or the Grantor's (or its designee's) authorized representative, to record this Release with the USPTO. The Administrative Agent hereby further authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 4. Further Assurances. The Administrative Agent hereby agrees to duly execute and deliver to the Grantor any further documents and to do such other acts that the Grantor (or its agents or designees) reasonably request, at the Grantor's sole cost and expense, in order to confirm this Release and the Grantor's right, title and interest in the Trademark Collateral.


SECTION 5. Applicable Law. THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.

SECTION 6. Counterparts. This Release may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this Release in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by fax transmission or by e-mail transmission shall be deemed an original signature hereto.
