## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of June 15, 2020, is made by BROWNELLS, INCORPORATED, an Iowa corporation, also known as Brownells, Inc. (the “**Grantor**”), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association (the “**Bank**”).

### WITNESSETH:

In order to secure the respective obligations of the Grantor, 2ND ADVENTURE GROUP, INC., an Iowa corporation (“**2nd Adventure**”), BROWNELLS INTERNATIONAL, INC., an Iowa corporation (“**Brownells International**”), BROWNELLS MANUFACTURING CO., an Iowa corporation (“**Brownells Manufacturing**”), BROWNELLS PROPERTIES INC., an Iowa corporation (“**Brownells Properties**”), and CROW SHOOTING SUPPLY, INC., an Iowa corporation (“**CSSI**”) (collectively, 2nd Adventure, Brownells International, Brownells Manufacturing, Brownells Properties and CSSI are hereinafter referred to as the “**Other Obligors**”) to the Bank under and pursuant to that certain Amended and Restated Credit Agreement of even date herewith (as the same may be amended, supplemented or restated from time to time); that certain that certain Sixth Amended and Restated Revolving Line of Credit Note of event date herewith, in the principal amount of up to \$65,000,000, executed and delivered by the Grantor and the Other Obligors in favor of Bank, as the foregoing may from time to time be modified, amended, extended, restated or replaced; and each and every other debt, liability and obligation of every type and description which the Grantor or Other Obligors (or any of them) may now or at any time hereafter owe to the Bank (whether such debt, liability or obligation now exists or is hereafter created or incurred, whether it arises under or is evidenced by this Agreement or any other present or future instrument or agreement or by operation of law, and whether it is direct or indirect, due or to become due, absolute or contingent, primary or secondary, liquidated or unliquidated, or sole, joint or joint and several) (all such debts, liabilities and obligations of the Grantor and Other Obligors (or any of them) to the Bank are herein collectively referred to as the “**Secured Obligations**”), the Grantor hereby agrees as follows:

1. Grant of Security Interest in Trademark Collateral. The Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations, hereby mortgages, pledges and hypothecates to the Bank and grants to the Bank a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of the Grantor (the “**Trademark Collateral**”):
  - (a) all of its Trademark Applications, Trademarks and all related Trademark Licenses providing for the grant by the Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;
  - (b) all renewals of the foregoing;
  - (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(d) all income, royalties and proceeds at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Bank pursuant to that certain Security Agreement of even date herewith executed by the Grantor and the Other Obligors in favor of the Bank (the “**Security Agreement**”) and the Grantor hereby acknowledges and agrees that the rights and remedies of the Bank with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
3. Grantor Remains Liable. The Grantor hereby agrees that, anything herein to the contrary notwithstanding, the Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with its Trademark Applications, Trademarks and related Trademark Licenses subject to a security interest hereunder.
4. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.
5. Governing Law. This Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the state of Iowa.

IN WITNESS WHEREOF, the Grantor has caused this Trademark Security Agreement to be executed and delivered by its duly authorized officer as of the date first set forth above.





