## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of June 16, 2020, is executed by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as agent for each member of the Lender Group and the Bank Product Providers (in such capacity, “Agent”), in favor of **FMG SUITE, LLC**, a Delaware limited liability company, and as successor in interest to Advisors Assistant Holdings, Inc., and Advisor Launchpad, Inc. (the “Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreements (as defined below).

### RECITALS

A. WHEREAS, the Grantor has pursuant to that certain (i) Trademark Security Agreement dated May 16, 2018, recorded in the United States Patent and Trademark Office (the “USPTO”) on May 30, 2018 at Reel 6338, Frame 0303, (ii) Trademark Security Agreement dated August 2, 2018, recorded in the United States Patent and Trademark Office (the “USPTO”) on October 29, 2018 at Reel 6469, Frame 0503, and (iii) Trademark Security Agreement dated September 28, 2018, recorded in the United States Patent and Trademark Office (the “USPTO”) on May 1, 2019 at Reel 6634, Frame 0156 (collectively, as each may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Trademark Security Agreements”) granted to Agent (for the benefit of itself and each member of the Lender Group and the Bank Product Providers) a Security Interest in and to all of the Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Agent, on behalf of itself and each member of the Lender Group and the Bank Product Providers, wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and each member of the Lender Group and the Bank Product Providers, hereby (i) irrevocably terminates, releases and discharges, without representation or warranty, the entirety of its Security Interest in and to the Released Collateral granted pursuant to the Trademark Security Agreements and, including but not limited to the goodwill of the business symbolized thereby and all proceeds thereof and (ii) terminates the Trademark Security Agreements. Agent hereby assigns, transfers and conveys, without recourse, representation or warranty, all right, title or interest of the Agent in the Released Collateral solely as granted to the Agent pursuant to the Trademark Security Agreements to the Grantor. Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Agent authorizes the Grantor and its designees to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and hereby agrees to provide the Grantor with any information and additional authorization and duly execute and deliver any further documents as, in each case, may be reasonably necessary to effect the release of the Security Interest in the Released Collateral.
