**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of June 15, 2020, by FMP Agency Services, LLC, as agent (in such capacity, the "Agent") for the Lender.

WITNESSETH:

WHEREAS, reference is made to that certain Term Loan and Security Agreement dated as of August 21, 2019 (as amended, restated, supplemented or otherwise modified from time to time, including all schedules thereto, the "Loan Agreement"), by and among, among others, Wholesome Sweeteners, Incorporated, a Delaware corporation ("Wholesome Sweeteners") and the Agent;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 21, 2019 (the "Original Trademark Security Agreement"), Wholesome Sweeteners granted a lien on and security interest (the "Security Interest") to the Agent in certain collateral, including the Collateral;

WHEREAS, the Original Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 22, 2019, at Reel/Frame 6726/0829; and

WHEREAS, the Agent now desires to terminate and release its Security Interest in the Trademarks listed on Schedule 1 hereto (the "Released Trademarks").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Original Trademark Security Agreement.
2. Release of Security Interest. The Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Released Trademarks, and any right, title or interest of the Agent in such Released Trademarks shall hereby cease and become void.
3. Recordation. The Agent authorizes Wholesome Sweeteners and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at Wholesome Sweeteners' sole expense.
