ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (this "Agreement") is made as of May 21, 2020 (the "Effective Date"), by and between DOMINIQUE SCHURMAN ("Buyer"), and SCHURMAN FINE PAPERS, a California corporation ("Seller"). Capitalized terms used herein and not otherwise defined herein have the meaning set forth in Article I.

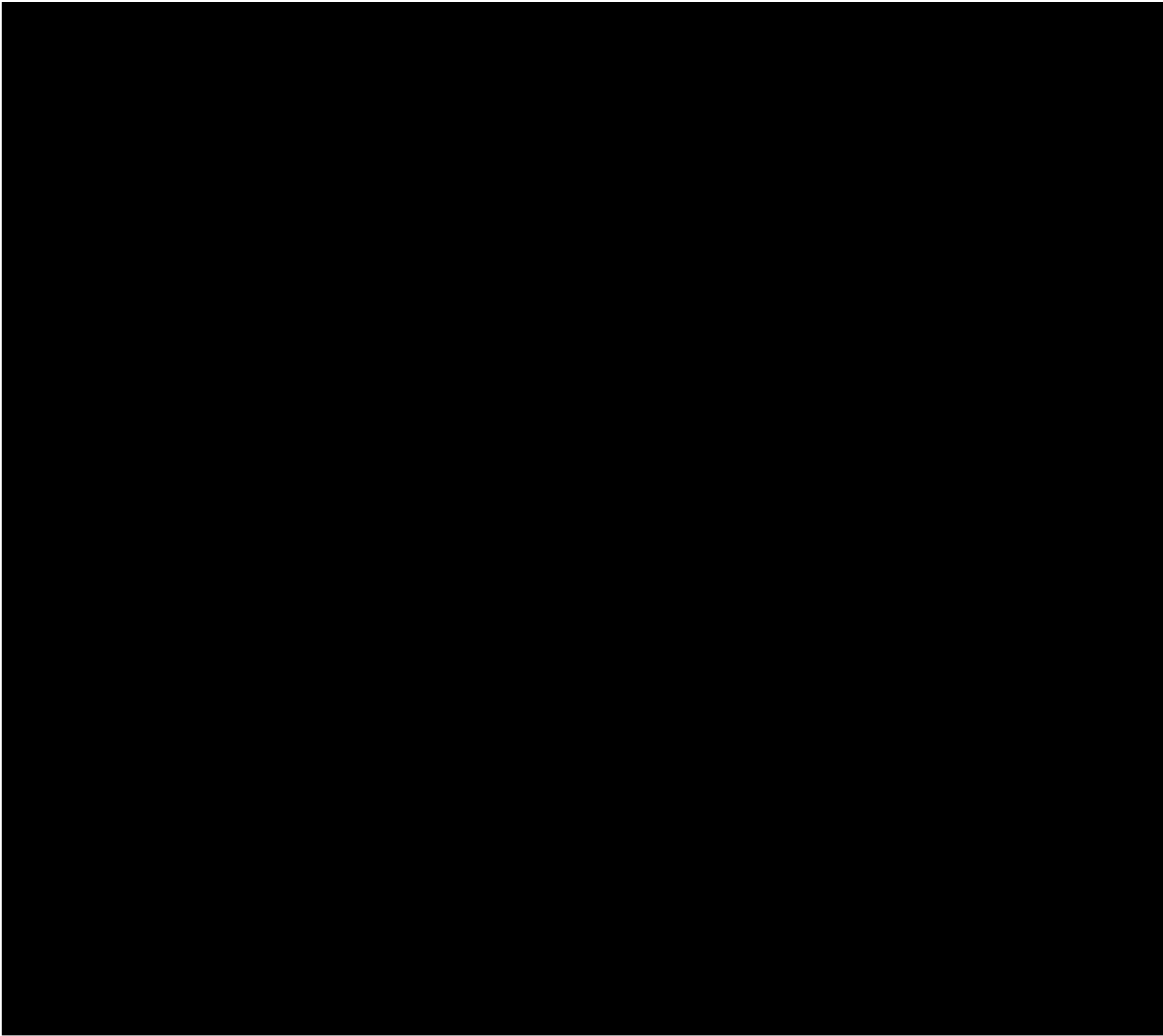

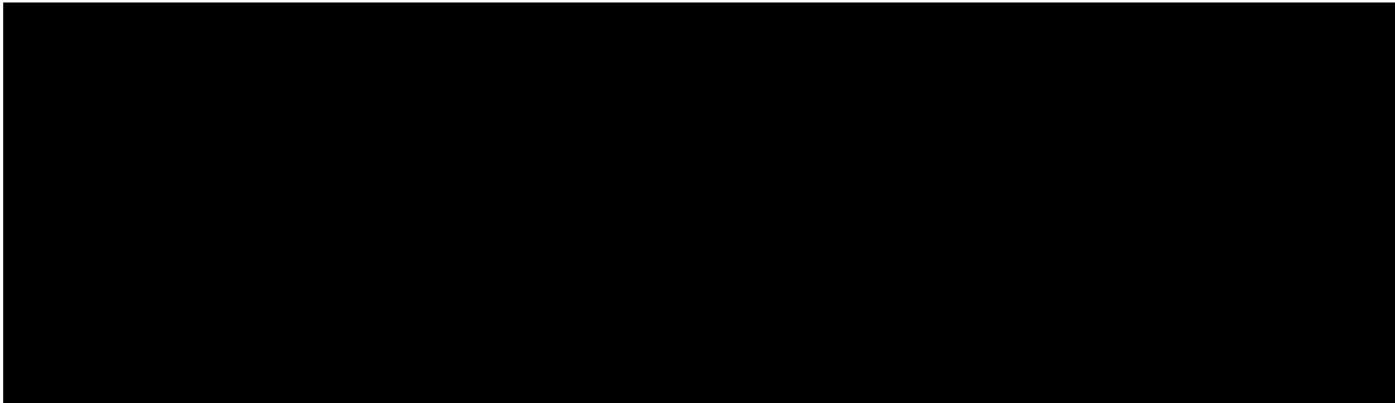
Section 1.1 Definitions. For purposes of this Agreement, the following terms have the meaning specified or referenced below.




