INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of May 6, 2020 (the “IP Agreement”) is executed by PHYSICIANS EXCLUSIVE LLC, a Wyoming limited liability company (the “Grantor”), to and for the benefit of CIBC BANK USA (the “Lender”) from time to time party to the Loan Agreement described below.

RECITALS:

A. Pursuant to a Loan and Security Agreement dated as of even date herewith entered into among Grantor, Lender and the persons designated therein as Loan Parties, (as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”) the Lender has agreed, subject to the terms and conditions thereof, to make certain loans and other financial accommodations to Grantor (collectively, the “Loans”). Capitalized terms used in this IP Agreement and not otherwise defined shall have the meanings given to them in the Loan Agreement.

B. Under the terms of the Loan Agreement, the Grantor (i) has granted to the Lender a security interest in and continuing lien on, among other property, all right, title and interest in, to and under all Intellectual Property of the Grantor, and (ii) has agreed to execute and deliver this IP Agreement for recording with national, federal, state, and foreign government authorities, including, but not limited to, the United States Patent and Trademark Office, the United States Copyright Office, and any other applicable Governmental Authority.

C. As a condition to the Lender entering into the Loan Agreement and making the Loans available, the Lender requires that the Grantor enter into this IP Agreement in order to secure the Borrower Obligations and the Loan Guarantor Obligations and performance of the Grantor hereunder and under the Loan Agreement.

NOW, THEREFORE, for and in consideration of the foregoing premises, which are hereby incorporated herein as true, and the mutual promises and agreements contained herein, the Grantor and the Lender hereby agree as follows:

1. Confirmation of Grant of Security. Grantor hereby confirms the pledge and grant to the Lender for the benefit of the Lender a security interest in and to all of the right, title and interest of Grantor in, to and under its Intellectual Property, now existing, or hereafter acquired, including and not limited to the following (the “IP Collateral”):

(a) All United States and foreign copyrights, including but not limited to copyrights in software and all rights in and to databases (whether or not copyrightable), and all mask works (as defined under 17 USC 901 of the US Copyright Act), whether registered or unregistered, whether published or unpublished, moral rights, reversionary interests, renewal rights, termination rights, and, with respect to any and all of the foregoing: (i) all registrations and applications therefor including, without limitation, any registrations and applications referred to in Schedule 1 hereto; (ii) all extensions and renewals thereof; (iii) all rights corresponding thereto throughout the world; (iv) all rights in any material that is copyrightable or that is protected by

common law, United States law, foreign laws, and/or the law of any State; (v) all rights to sue for past, present, and future infringements and misappropriations thereof and to enjoin or collect damages for the actual or threatened infringement and misappropriation thereof; (vi) all Proceeds of the foregoing, now or hereafter due and payable, including but not limited to licenses, royalties, income, payments, claims, damages, and proceeds of suit; and (vii) all tangible property embodying the copyrights and/or such copyrighted materials (collectively, the “Copyrights”).

(b) All United States and foreign patents, certificates of invention, industrial property, industrial designs, design rights, plant rights, and any other protection for an invention, however named, including, but not limited to: (i) all issued patents, provisional applications, and applications referred to in Schedule 1 hereto; (ii) all reissues, divisionals, continuations, continuations-in-part, extensions, renewals, reexaminations therefor, and amendments thereof; (iii) all rights corresponding thereto throughout the world; (iv) all inventions and improvements described therein; (v) all rights to sue for past, present and future infringements and misappropriations thereof and to enjoin or collect damages for the actual or threatened infringement and misappropriation thereof; (vi) all licenses, claims, damages, and proceeds of suit arising therefrom; and (vii) all Proceeds of the foregoing, now or hereafter due and payable, including but not limited to licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “Patents”).

(c) All United States and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, uniform resource locators (URLs), service marks, certification marks, collective marks, logos, trade dress, slogans, other source or business identifiers, design marks, general intangibles of a like nature, all common law rights in any of the foregoing, and all registrations and applications for any of the foregoing including, but not limited to (i) the registrations and applications referred to in Schedule 1 hereto, excluding only (A) United States applications claiming an intent-to-use basis to the extent that, and solely during the period in which, the grant, attachment, or enforcement of a security interest therein would, under applicable federal law, impair the registrability of such applications or the validity or enforceability of registrations issuing from such applications and (B) any registration or application referred to in Schedule 1 hereto listed as “Abandoned”; (ii) all divisionals, extensions, and renewals of any of the foregoing; (iii) all of the goodwill of the business associated with the use of and symbolized by the foregoing, now existing or hereafter adopted or acquired; (iv) the right to sue for past, present and future infringement, misappropriation, or dilution of any of the foregoing and/or for any injury to goodwill, and to enjoin or collect damages for the actual or threatened infringement, misappropriation, dilution, or injury to goodwill thereof; and (v) all Proceeds of the foregoing, now or hereafter due and payable, including but not limited to licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “Trademarks”).

(d) All trade secrets and all other confidential and/or proprietary information and know-how, regardless of whether such trade secret, information, or know-how has been reduced to a writing or other tangible form, including all documents and things embodying, incorporating, or referring in any way to such trade secret, information, or know-how including but not limited to the right to sue for past, present and future theft, misappropriation, or other

violation of any trade secret, information, or know-how and to enjoin or collect damages for the actual or threatened theft, misappropriation, or other violation of any trade secret, information, or know-how; and (iii) all Proceeds of the foregoing, now or hereafter due and payable, including but not limited to licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “Trade Secrets”).

(e) All licenses, covenants not to sue, and agreements, whether written or oral, including but not limited to any foreign licenses, covenants not to sue, and agreements listed in Schedule 1, providing for the grant by or to any Grantor of: (A) any right to use any Trademark or Trade Secret or any other trademark, trade name, corporate name, company name, business name, fictitious business name, Internet domain name, uniform resource locator (URL), service mark, certification mark, collective mark, logo, slogan, trade dress, other source or business identifier, design mark, trade secret, other confidential and/or proprietary information, or know-how; (B) any right to manufacture, use, import, export, distribute, offer for sale, or sell any invention covered in whole or in part by a Patent or any other patent, certificate of invention, industrial design, design right, plant right, or any other protection for an invention, however named; and (C) any right under any Copyright or any other copyright; including, without limitation the grant of rights to make, use, offer for sale, import, export, reproduce, prepare derivative works, distribute, perform, display publicly, transmit, exploit, and sell materials embodying, bearing, or derived from any Copyrights, Patents, Trademarks, and/or Trade Secrets including, without limitation, any of the foregoing identified in Schedule 1 hereto; (E) the right to sue and otherwise recover for any and all past, present and future infringements, dilution, injury to goodwill, theft, and misappropriations and to enjoin or collect damages for the actual or threatened infringement, dilution, injury to goodwill, theft, and misappropriation of any of the foregoing; (F) all Proceeds of the foregoing, including but not limited to income, royalties, damages, proceeds of suit, and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof); (G) all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; but all of the foregoing (A)-(G) excluding any off-the-shelf, “click-wrap,” or “shrink-wrap” software license agreement.

2. Recordation. Grantor authorizes the Register of Copyrights, the Commissioner of Patents and Trademarks and any other applicable government officer to record this IP Agreement upon request by the Lender.

3. Loan Documents. This IP Agreement has been entered into pursuant to and in conjunction with the Loan Agreement. The provisions of the Loan Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of the Lender with respect to the Collateral, including the IP Collateral, are as provided by the Loan Agreement and related documents, and nothing in this IP Agreement shall be deemed to limit such rights and remedies.

4. Execution in Counterparts. This IP Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an

executed counterpart of a signature page to this IP Agreement by facsimile or in electronic (i.e., “pdf” or “tif”) format shall be effective as delivery of a manually executed counterpart of this IP Agreement.

5. Successors and Assigns. This IP Agreement and all rights and liabilities hereunder and in and to any and all IP Collateral shall inure to the benefit of the Lender and its successors and permitted assigns, and shall be binding on the Grantor, its administrators, successors and assigns.

6. Governing Law. This IP Agreement has been made and entered into in Illinois and shall be governed by and construed in accordance with the laws of the State of Illinois.

7. Duration and Effect. This IP Agreement shall remain and continue in full force and effect (notwithstanding, without limitation, the dissolution of Grantor) from the date hereof until all of the Borrower Obligations have been Paid in Full. Thereupon, this IP Agreement shall automatically terminate and the Lender shall release any IP Collateral still subject to a lien to secure the Borrower Obligations which has not been sold or otherwise disposed of in accordance with the Loan Agreement and applied toward the satisfaction of the Borrower Obligations hereunder, and the Lender shall release its lien on any such IP Collateral, and deliver any necessary assignment, release of security interest or payoff letter executed by the Lender in blank. Grantor acknowledges that this IP Agreement is and shall be effective upon execution by the Grantor and delivery to and acceptance hereof by the Lender, and it shall not be necessary for the Lender to execute any acceptance hereof or otherwise to signify or express its acceptance hereof to the Grantor.

8. Joinder of Additional Loan Parties. Upon execution and delivery by any Person of a joinder agreement substantially in the form of Exhibit A (a “Joinder”), such Person shall become a Grantor hereunder with the same force and effect as if originally named as a Grantor herein. The execution and delivery of a Joinder adding an additional Person as a party to this Agreement shall not require the consent of any other Grantor hereunder. The rights and obligations of each Grantor hereunder shall remain in full force and effect notwithstanding the addition of any new Grantor as a party to this Agreement.



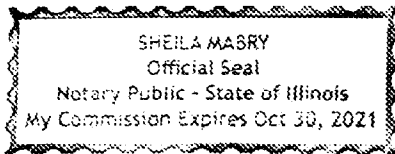


