**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 16, 2020 (“Release”), is made by Pacific Western Bank (“Lender”) in favor of Canvas Solutions, Inc., a Delaware corporation (“Grantor”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of November 30, 2016, by and among the Grantor and Lender (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), Grantor granted to the Lender a continuing security interest in Grantor’s right, title and interest in and to all Trademarks, Trademark Licenses, and Proceeds of the foregoing (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Lender that certain (i) Trademark Assignment Cover Sheet recorded at the United States Patent and Trademark Office (“USPTO”) on June 26, 2018, at Reel 006365 Frame 0749 (“Notice #1”) and (ii) Trademark Assignment Cover Sheet recorded at the USPTO on March 14, 2019, at Reel 006591 Frame 0187 (“Notice #2”; together with Notice #1, the “Notices”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Notices.


SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby terminates, cancels, discharges, and releases the security interest in Grantor’s right, title, and interest in and to all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or the Notices.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of North Carolina.
