RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of June 19, 2020 ("Effective Date") in favor of DAL GLOBAL SERVICES, LLC, a Delaware limited liability company ("Grantor"), by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Secured Party").

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 21, 2018, at Reel 006506, Frame 0987; and

WHEREAS, the Secured Party has agreed to release its liens on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademarks, and (iii) re-assigns to Grantor any right, title and interest, together with the goodwill of the Grantor's business connected with and symbolized by the Trademarks, it may have in, to and under the Trademarks to Grantor.
