RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of June 19, 2020 ("Effective Date") in favor of DAL GLOBAL SERVICES, LLC, a Delaware limited liability company (the "Grantor"), by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Lender (together with its successors and assigns, the "Lender").

WHEREAS, Grantor and the Lender entered into that certain Security Agreement by, among others, Grantor in favor of the Lender, dated as of June 20, 2019 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor granted to the Lender a security interest in all of its right, title and interest in, to and under certain intellectual property and entered into that certain Trademark Security Agreement, dated as of June 20, 2019 (the "Trademark Security Agreement"), for the purpose of recording such security interest with respect to the trademarks and applications therefor of Grantor, including those items set forth on Schedule I hereto (collectively, the "Trademark Collateral"), with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 20, 2019, at Reel 6675, Frame 0017; and

WHEREAS, the Lender has agreed to release its liens on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (iii) re-assigns to Grantor any right, title and interest, together with the goodwill of the Grantor's business connected with and symbolized by the trademarks, it may have in, to and under the Trademark Collateral to Grantor.
