Notice of Right to Use Registered Mark

Whereas, those named immediately below are parties to a prior dispute in the United States District Court, Eastern District of Pennsylvania, as hereinafter described, (the "Litigation") who have entered into a Settlement Agreement and Mutual General Release ("Agreement"), effective as of May 5, 2020; and

Whereas, the parties to the Litigation are John Tacconelli, an individual ("John"), Tacconelli's Empire, LLC, a New Jersey limited liability company ("Tacconelli's Empire"), Vincent Tacconelli, Jr., an individual and SugarHouse Gaming, L.P., a Delaware limited partnership, each referred to as a "Party," or collectively as the "Parties."

Now, Therefore, this Notice is being filed in accordance with the Agreement as follows:

1. The Litigation previously pending in the United States District Court in the Eastern District of Pennsylvania, was a civil action captioned as *John Tacconelli v. Tacconelli's Empire LLC, SugarHouse HSP Gaming, L.P. and Vincent Tacconelli, Jr.*, Civil Action No 16-2348 (CDJ).
2. The dispute involved, *inter alia*, rights to Service Mark Registration No. 2,700,210 (the "Registration") for the mark, TACCONELLI'S PIZZERIA (the "Mark") and associated allegations of common law trademark infringement.
3. Tacconelli's Empire is listed in the Registration as the current owner of the Mark.
4. The Agreement, the specific terms of which are confidential, resolves the Litigation and the matters disputed therein.
5. Among other things, the Agreement grants to John certain rights to use the Mark, which rights include, but are not limited to, the right of successorship in the Mark under certain circumstances as described therein.
6. The Agreement provides for the filing of this Notice with the U.S. Patent & Trademark Office by the attorney for Tacconelli's Empire, LLC, the current owner of the Mark.
