**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of June 19, 2020 (this "Release"), is made by WILMINGTON SAVINGS FUND SOCIETY, FSB, in its capacity as collateral agent (in such capacity, "Agent"), in favor of TECHNIPLAS, LLC ("Techniplas") and NYLONCRAFT, INC. (together with Techniplas, the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Grantors and the Agent entered into that certain Trademark Security Agreement, dated as of April 21, 2020 (the "Trademark Security Agreement"), pursuant to which the Grantors pledged and granted to the Agent a security interest in and to all of their right, title and interest in, to and under the Collateral (as defined therein), including without limitation, the trademark registrations and applications listed on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on: April 21, 2020 at Reel 6920 and Frame 0232, with respect to the trademarks owned by the Grantors; and

WHEREAS, the Grantors have requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Collateral.

NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Trademark Security Agreement in the Collateral, (b) discharge and release its security interest in and to the Collateral, and (c) reassign any and all rights, title and interest it has in the Collateral to Grantors.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
