## GLOBAL TRADEMARK AND DOMAIN NAME ASSIGNMENT

Assignor assigns, transfers, conveys and delivers to the Assignee and its successors and assigns, and the Assignee accepts from the Assignor, all of Assignor’s rights, title and interest in, to, and under the Assigned Trademarks and Domains, including, without limitation, all common law trademarks for which no applications or registrations exist, all applications to register any of the Assigned Trademarks and Domains, and all registrations that have been or may be granted for any of the Assigned Trademarks and Domains, together with all common law rights associated with the applications and registrations, and all goodwill associated with the Assigned Trademarks and Domains and symbolized thereby, along with that portion of the business which is ongoing and existing to which the trademarks pertain, together with the right to sue and recover damages for future, present, and past infringements of the Assigned Trademarks and Domains and to fully and entirely stand in the place of the Assignor in all matters related to the Assigned Trademarks and Domains.

2. Further Assurances.

a. The Assignor agrees to execute and deliver such other documents and to take all such other actions which the Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment, and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably required to effect the terms of this Assignment and its recordation in relevant state and national trademark offices.

b. Assignor grants the attorney of record the power to insert on this Assignment any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office, or rules of other entities including but not limited to United States or foreign governments or patent offices, for recordation of this document.

c. Assignor represents that Assignor has the rights, titles, and interests to convey as set forth herein, and covenants with Assignee that the Assignor has not made and will not hereafter make any assignment, grant, mortgage, license, or other agreement affecting the right, title, and interest herein conveyed.


3. This Assignment may not be supplemented, altered or modified in any manner except by a writing signed by each party. The failure of any party to enforce any terms or provisions of this

Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall bind and inure to the benefit of the respective parties and their assigns, transferees and successors.

4. This Assignment may be executed in one or more counterparts, and by each party in separate counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement.


