**DECLARATION OF CARRIE L. COGBURN**

My name is Carrie L. Cogburn. I am Senior Vice President and Senior Corporate Counsel of BBVA USA Bancshares, Inc., a Texas corporation previously known as BBVA Compass Bancshares, Inc. (“BBVA”). I make this declaration upon my own personal knowledge and belief.


BBVA is listed as record owner of U.S. Registration No. 1,583,904 (the “Registration”). On information and belief, that listing is in error. Based on the assignment record for the Registration, on or about February 16, 2010, Compass Bank, then the owner of record, assigned the entire interest and goodwill in the Registration to Community Bancshares of Mississippi, Inc. (“CBM”). This assignment was recorded on or about February 18, 2010 at Reel/Frame 4151/0385. Subsequently, two additional documents were recorded with the USPTO that, on information and belief, inadvertently included the Registration in error: (1) an assignment form recorded on or about May 8, 2012 at Reel/Frame 4775/0191 reflecting that Compass Bancshares, Inc., an Alabama corporation (successor-in-interest to certain assets of Compass Bank) changed its name to BBVA Compass Bancshares, Inc.; and (2) a merger agreement recorded on or about May 21, 2013 at Reel 5031/0698, reflecting that BBVA Compass Bancshares, Inc. merged with BBVA (together, the “BBVA Assignment Forms”). As a result, the assignment records for the Registration have erroneously identified BBVA or a predecessor entity as the owner of the Registration since May 8, 2012.

On December 16, 2014, Brian R. Herrick of BBVA submitted a Revocation of Attorney and Appointment of Attorney form (“Power of Attorney”) that appointed Jason S. Howell of

Perkins Coie LLP as attorney of record for the Registration. On information and belief, this Power of Attorney was inadvertently filed in error.

To confirm, BBVA makes no claim of ownership to the Registration and requests that the USPTO correct the record for the Registration by (a) amending each of the BBVA Assignment Forms to remove the reference to the Registration, and (b) disregarding the Power of Attorney with respect to the Registration. For the avoidance of doubt, this request has no bearing on nor applies to the ownership of or appointment of attorney by BBVA of any other active trademark filings on the Principal or Supplemental Register of the USPTO currently held in the name of BBVA.

The signatory being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or submission or any registration resulting therefrom, declares that all statements made of his/her own knowledge are true and all statements made on information and belief are believed to be true.
