SGS NORTH AMERICA INC., (hereinafter "Corporation") a corporation incorporated on the 18th day of March, 1980, pursuant to the provisions of the General Corporation Law of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the Corporation was organized pursuant to the General Corporation Law of the State of Delaware, on the 18th day of March 1980.

SECOND: That the Corporation owns 100% of the capital stock of SGS Govmark Testing Services, Inc., a corporation incorporated on the 29th day of December 2010 in the State of New York.

THIRD: That the Corporation, by resolution of its Board of Directors, duly adopted on December 11, 2019 by written consent of its members, filed with the Minutes of the Board, determined to and did merge into itself said SGS Govmark Testing Services, Inc., to be effective as of the close of business on December 31, 2019, and did adopt the following resolutions:

RESOLVED, that SGS North America Inc. does hereby merge into itself its wholly owned subsidiary, SGS Govmark Testing Services, Inc. and SGS North America Inc. assumes all of the obligations of SGS Govmark Testing Services, Inc.

FURTHER RESOLVED, that the terms and conditions of the merger are as follows:


SGS North America Inc. at present owns all of the outstanding shares of stock of the subsidiary corporation, SGS Govmark Testing Services, Inc. On the effective date of the merger, all of the outstanding shares of stock of SGS Govmark Testing Services, Inc. shall be surrendered and cancelled. The shares of common stock of SGS North America Inc., whether authorized or issued on the effective date of the merger, shall not be converted, exchanged or otherwise effected as a result of the merger, and no new shares of stock be issued by reason of this merger.
