ASSIGNMENT AGREEMENT

WHEREAS, Assignor is the owner of all right, title and interest in the trademarks, trademark registrations and trademark applications set forth on Schedule A annexed hereto; and

WHEREAS, Assignee wishes to acquire all right, title and interest in the trademarks, the trademark registrations and trademark applications set forth on Schedule A, together with the goodwill of the business connected with the use of, and symbolized by, the trademarks provided that, with respect to the United States intent-to-use (ITU) trademark applications set forth on Schedule A, the transfer of such applications accompanies the transfer of Assignor’s business, or that portion of the business to which the trademarks pertain, and that business is ongoing and existing.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, said Assignor irrevocably conveys, transfers and assigns to Assignee all of its right, title and interest in and to the following:

1. the trademarks, the trademark registrations and trademark applications set forth on Schedule A hereto and all issuances, extensions, and renewals thereof, together with the goodwill of the business connected with the use of, and symbolized by, the trademarks, and with respect to

the United States ITU trademark applications set forth on Schedule A, Assignor's business, or that portion of the business to which the trademarks pertain, and that business is ongoing and existing;

2. all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;


3. any and all royalties, fees, income, payments, and other proceeds now or hereafter due to payable with respect to any and all of the foregoing; and

4. any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
