## Termination of Security Interest

THIS TERMINATION OF SECURITY INTEREST (this "Termination"), dated as of June 19, 2020, is executed by FIFTH THIRD BANK, NATIONAL ASSOCIATION (successor in interest to MB Financial Bank, N.A.), as Administrative Agent, in favor of QUEST PRODUCTS, LLC, a Delaware limited liability company (the "Company").

A. To secure the payment, performance, and observance of the Obligations (as that term is defined in that certain Credit Agreement, dated as of February 16, 2018, by and among, *inter alia*, the Administrative Agent and the Company (the "Credit Agreement")), the Company granted to the Administrative Agent a security interest, pursuant to that certain Grant of Security Interest in Trademarks, dated as of October 26, 2018, executed by the Company in favor of the Administrative Agent and recorded with the United States Patent and Trademark Office (the "USPTO") on October 30, 2018 at Reel/Frame: 6470/0378 (the "Trademark Security Agreement"), in the Collateral described therein, including, but not limited to, the trademarks, trademark registrations, trademark applications, and trademark licenses set forth on Schedule 1 annexed to this Termination and made part of this Termination for all purposes (such Collateral, the "Trademark Collateral").

B. The Administrative Agent now wishes to terminate the security interest in the Trademark Collateral.

C. All capitalized terms used herein not otherwise defined herein have the meanings given to them in the Credit Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Administrative Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

1. terminates the Trademark Security Agreement;
2. terminates, cancels, discharges and releases any and all liens on and its security interest in and to the Trademark Collateral arising under the Trademark Security Agreement, including, but not limited to, the trademarks, trademark registrations, trademark applications, and trademark licenses set forth on Schedule 1 annexed to this Termination; and
3. authorizes the recordation of this Termination with the USPTO at the Company's expense.

THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF ILLINOIS WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES.
