**TERMINATION AND RELEASE OF
SECURITY INTEREST**

This Termination and Release of Security Interest (“**Release**”) is made and entered into as of May 29, 2020 by Riverside Merchant Partners, LLC, a New York limited liability company; Adam L. Kinzer Inc., a New York corporation (erroneously referred to as Adam L. Kinser Inc., a New York corporation, due to a typographical error in the Trademark Assignment Cover Sheet attaching the Security Agreement (as hereinafter defined)); Sherbrooke Holdings LLC, a New York limited liability company; and Zachary Hirschothe Deposit Irrevocable Trust, a trust organized in the state of New York (each a “**Lender**,” and collectively the “**Lenders**”), in favor of Popshots LLC, a Delaware limited liability company, and its assigns (collectively, “**Borrower**”).

WHEREAS, pursuant to that Intellectual Property Security Agreement entered into as of February 6, 2019 (“**Security Agreement**”), by and among Borrower and Lenders, Borrower granted and assigned to Lenders a security interest in and lien on certain interests in the trademark LIQS (Registration No. 4,540,186) and related collateral as defined in the Security Agreement (collectively, the “**Collateral**”), which Security Agreement was duly recorded with the United States Patent and Trademark Office on March 7, 2019, at Reel: 006584 Frame: 0133.

WHEREAS, Borrower has satisfied all of its obligations to Lenders under the Security Agreement, and Lenders now wish to terminate the Security Agreement, release their security interest and lien, and retransfer, and reassign to Borrower all of Lenders’ right, title and interest in the Collateral.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lenders hereby unconditionally and irrevocably terminate the Security Agreement, terminate and release their security interest in and lien on the Collateral, and Lenders hereby reassign to Borrower, without warranty or recourse, all of Borrower’s right, title, and interest in and to the Collateral.

This Termination and Release of Security Interest may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.






