In accordance with the provisions of Article 10 of Law No. 1.355 of December 23, 2008 concerning associations and federations of associations, the State Ministry delivers the receipt of the declaration of the amendment of the statutes received on October 29, 2019 of the association named "INTERNATIONAL ASSOCIATION OF ATHLETICS FEDERATIONS", in short, "I.A.A.F.".

These amendments relate to:


- the denomination which becomes "WORLD ATHLETICS",
- the object whose wording has been slightly reviewed in order to delete the mention "at all levels" when referring to the world-wide promotion of sporting interests in general and of athletics in particular, and to specify in relation to undoped athletes that they "compete in athletics",
- as well as an overhaul of the statutes,

the above amendments comply with the law governing associations.
