**RELEASE OF TRADEMARK SECURITY INTEREST**

RELEASE OF TRADEMARK SECURITY INTEREST dated as of June 25, 2020 (this "***Trademark Security Release***"), by CREDIT SUISSE AG, as administrative agent and collateral agent (the "***Agent***"), in favor of MERISANT COMPANY, WHOLE EARTH SWEETENER COMPANY LLC and MAFCO WORLDWIDE LLC (formerly known as Mafco Worldwide Corporation) (each a "***Grantor***" and together the "***Grantors***"). Reference is made to (a) that certain Second Lien Guarantee and Collateral Agreement dated as of October 3, 2014 (as may be amended, restated, supplemented, replaced and otherwise modified from time to time, the "***Guarantee and Collateral Agreement***"), among the grantors party thereto and the Agent, (b) that certain Second Lien Intellectual Property Security Agreement dated as of October 3, 2014 (as amended, supplemented or otherwise modified from time to time, the "***Second Lien Intellectual Property Security Agreement***"), among the Grantors and the Agent and (c) that certain After-Acquired Intellectual Property Security Agreement (First Supplemental Filing) dated as of May 8, 2015 (as amended, supplemented or otherwise modified from time to time, the "***Second Lien First Supplemental Intellectual Property Security Agreement***", and together with the Guarantee and Collateral Agreement and the Second Lien Intellectual Property Security Agreement, the "***Security Documents***"), among the Grantors and the Agent.

WHEREAS, pursuant to the terms and conditions of the Security Documents, each Grantor granted to the Agent a security interest in and to all of such Grantor's right, title and interest in or to any and all Collateral (as such term is defined in the Guarantee and Collateral Agreement), and Intellectual Property Collateral (as such term is defined in each of the Second Lien Intellectual Property Security Agreement and Second Lien First Supplemental Intellectual Property Security Agreement) (collectively, the "***Released Trademark Collateral***"), including, but not limited to, the following:

- (a) the trademark and service mark registrations and applications set forth on Schedule A hereto; and
- (b) all Proceeds (as such term is defined in the Guarantee and Collateral Agreement) and products of any and all of the foregoing and all collateral security and guarantees given by any Person with respect to any of the foregoing.

WHEREAS, the security interest in the Released Trademark Collateral was recorded with the United States Patent and Trademark Office on October 17, 2014 at Reel/Frame No. 5382/0796, on May 8, 2015 at Reel/Frame No. 5513/0214 on May 8, 2015 at Reel/Frame No. 5513/0223, and on May 8, 2015 at Reel/Frame No. 5513/0232.

WHEREAS, the Agent now desires to execute and deliver this Trademark Security Release to evidence the release of its lien on and security interest in and to the Released Trademark Collateral on the terms and subject to the conditions hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent and the Grantors hereby agree as follows:

SECTION 1. Release of Security Interest. The Agent discharges and releases and conveys to the Grantors, without recourse, representation or warranty of any kind, all of the Agent's security interest in, and right, title and interest in and to, the Released Trademark Collateral.

SECTION 2. Governing Law. This Trademark Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 3. Miscellaneous. The Agent hereby (i) authorizes the Grantors and their successors, assigns or other legal representatives to make filings with the United States Patent and Trademark Office at the expense of the Grantors, and (ii) agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary, in each case, to evidence and effect the release and termination of the Agent's security interests in the Released Trademark Collateral.
