**Trademark Assignment**

Assignee assumes all of Assignor’s obligations under any license or other agreement applicable to any of the Marks.

Assignee shall indemnify, defend, and hold harmless Assignor against all damages, losses, costs, actions, claims, allegations, attorneys’ fees, and other liabilities arising out of or related to the Marks or use thereof, whether past, present, or future.
