## Trademark Assignment

This Trademark Assignment Agreement (the "**Agreement**") is effective this 25 day of June, 2020 by and between OptumInsight, Inc., a Delaware corporation ("**Assignor**") and OptumInsight Life Sciences, Inc., a Delaware corporation, with a principal address of 640 George Washington Highway, Lincoln, Rhode Island 02865 ("**Assignee**").

Assignor hereby irrevocably transfers and assigns to Assignee all of Assignor's rights in and to the Trademark, including, but not limited to: (a) all common law and statutory rights related thereto, all rights of renewal and extension; (b) the right to apply for registration in the United States of America and all foreign countries; (c) the right to sue for, settle and release past, present and future infringement of the Trademark; and (d) the goodwill of the business symbolized by the Trademark.
2. From time to time, Assignor will, at Assignee's request and without further consideration, execute and deliver such instruments of sale, transfer, conveyance, assignment and confirmation, and to perform any other reasonable acts Assignee may reasonably request in order to more effectively sell, transfer, convey and assign to Assignee all of Assignor's right, title, and interest in and to the Trademark.
