RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (“Release”) is given on this 29th day of June 2020, by DEERPATH FUND SERVICES, LLC, as administrative agent and collateral agent for the Lenders (in such capacities, the “Agent”) for Obsession Bows, LLC (the “Grantor”), as follows:

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of itself, hereby covenants and agrees as follows:

The Agent hereby releases any security interest it may have in the Trademarks listed on Schedule A, and reassigns any and all right, title and interest it may have in and to the Trademarks without recourse to the Grantor.

The Agent hereby agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


