TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT**, dated as of May 21, 2020 (this "Agreement"), is made by each of the signatories hereto indicated as a "Grantor" (each a "Grantor" and collectively, the "Grantors") in favor of UBS AG, STAMFORD BRANCH, as Security Trustee for the Secured Parties (in such capacity and together with its successors and assigns in such capacity, the "Security Trustee").

WHEREAS, pursuant to that certain Syndicated Facility Agreement dated as of May 21, 2020 by and among Aristocrat Leisure Limited ACN 002 818 368, a corporation registered in New South Wales ("Holdings"), Aristocrat International Pty Ltd ACN 000 148 158, a corporation organized under the laws of New South Wales and Delaware ("AIP"), Aristocrat Technologies Australia Pty Limited ACN 001 660 715, a corporation registered in New South Wales ("ATA"), Aristocrat Technologies, Inc., a Nevada corporation ("ATI"), Video Gaming Technologies, Inc., a Tennessee corporation ("VGT" and, collectively with AIP, ATA and ATI, the "Borrowers"), the banks and other financial institutions or entities from time to time party thereto (the "Lenders") and UBS AG, Stamford Branch, as administrative agent for the Lenders and as Security Trustee (as the same may hereafter be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Syndicated Facility Agreement"), the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and conditions set forth therein; and

WHEREAS, as a condition precedent to the obligation of the Lenders to make their respective extension of credit to the Borrowers under the Syndicated Facility Agreement, the Grantors entered into a Security Agreement dated as of May 21, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") between, among others, each of the Grantors and the Security Trustee, pursuant to which each of the Grantors assigned, transferred and granted to the Security Trustee, for the benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, each Grantor agreed to execute this Agreement, in order to record the security interest with respect to the Trademark Collateral granted to the Security Trustee for the benefit of the Secured Parties with the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantors hereby agree with the Security Trustee as follows:

SECTION 1. Defined Terms

Capitalized terms used but not defined herein shall have the respective meanings given thereto in the Security Agreement, and if not defined therein, shall have the respective meanings given thereto in the Syndicated Facility Agreement.

SECTION 2. Grant of Security Interest

SECTION 2.1 Grant of Security. Each Grantor hereby grants to the Security Trustee, for the benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in and to the following property now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral") as collateral security for the payment or performance, as the case may be (whether at the stated maturity, by acceleration or otherwise), of the Secured Obligations:

(i) those trademarks and trademark applications listed in Schedule A (except for "intent to use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of said Act has been filed), and (ii) the right to obtain all renewals thereof, (iii) rights to sue at law or in equity for any infringement or other violations thereof, (iv) Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto, and (v) other rights of any kind accruing thereunder or pertaining thereto throughout the world.

SECTION 2.2 Certain Limited Exclusions. Notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include or the security interest granted under Section 2.1 hereof attach to any "intent-to-use" application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the Lanham Act or an "Amendment to Allege Use" pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such application or any registration that issues from such intent-to-use application under applicable federal law.

SECTION 3. Security Agreement

The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Security Trustee for the Secured Parties pursuant to the Security Agreement, and the Grantors hereby acknowledge and affirm that the rights and remedies of the Security Trustee with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Governing Law

THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO PRINCIPLES OF CONFLICTS OF LAWS TO THE EXTENT THAT THE SAME ARE NOT MANDATORILY APPLICABLE BY STATUTE AND THE

APPLICATION OF THE LAWS OF ANOTHER JURISDICTION WOULD BE REQUIRED THEREBY.

SECTION 5. Counterparts; Electronic Execution

This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Any soft copy so signed will constitute an executed original counterpart. In addition, where the document is printed having been electronically signed such that the relevant signatures appear in the printout as and when signed electronically, any such print-outs will also be an executed original counterpart. The words “execution,” “signed,” “signature,” and words of like import in this Agreement or in any amendment or other modification hereof (including waivers and consents) shall be deemed to include signatures by facsimile or electronic transmission (including, but not limited to, DocuSign, “JPEG”, “pdf” or “tiff”) or the keeping of records in electronic form, and delivery of any such executed document by facsimile or electronic transmission (including, but not limited to, DocuSign, “JPEG”, “pdf” or “tiff”) shall be of the same legal effect, validity or enforceability as a manually executed and delivered signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.


SECTION 6. Capacity of the Security Trustee
