NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor has sold, assigned, transferred and set over, and by these presents do sell, assign, transfer and set over, unto Assignee, its successors, legal representatives and assigns, the entire right, title and interest in and to the Trademark together with: (1) the goodwill of the business relating to the goods and services upon which the Trademark is used and for which it is and will be registered; and (2) all rights to sue for past, present and future infringements or misappropriations of the Trademark; the same to be held and enjoyed by Assignee, for its own use and benefit and the use and benefit of its successors, legal representatives and assigns, to the full end of the term of the Trademark registration, as fully and entirely as the same would have been held and enjoyed by Assignor, had this assignment not been made.


AND, Assignor and Assignee will cooperate and consult with one another in good faith, if necessary in the future to carry out the intent of this document.
