**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of July 1, 2020, is made by Deutsche Bank AG New York Branch, in its capacity as collateral agent (the "Collateral Agent"), in favor of Mobile Storage Group, Inc., a Delaware corporation, A Royal Wolf Portable Storage, Inc., a California corporation, Mobile Mini, Inc., a Delaware corporation, Mobile Mini Tank and Pump Solutions, Inc., a Delaware corporation (f/k/a Evergreen Tank Solutions, Inc., a Delaware corporation, and also successor by merger to Water Movers, Inc., an Arizona corporation) and SBOX STORAGE, LLC, a Delaware limited liability company (collectively, the "Grantors"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement, dated as of February 22, 2012 (as amended, modified, restated, amended and restated and/or supplemented from time to time, the "Security Agreement"), by the Grantors and the other parties party thereto in favor of the Collateral Agent, and those certain agreements described on Annex I attached hereto (the "IP Security Agreements" and, collectively with the Security Agreement, the "Security Agreements"), the Grantors granted a security interest (the "Security Interest") in certain collateral in favor of the Collateral Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Collateral Agent now desires to terminate and release the IP Security Agreements and the entirety of its Security Interest in the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "IP Collateral", as used herein, shall mean all of the Grantors' right, title and interest in, to and under the Copyrights, Patents and Marks listed on Annex II attached hereto. Capitalized terms not defined herein have the meanings set forth in the Security Agreements, as applicable.

2. Release of Security Interest. The Collateral Agent, without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of Grantors, and their successors and assigns, its Security Interest in and to the IP Collateral, and the IP Security Agreements and any and all right, title and interest of the Collateral Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Collateral Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and United States Copyright Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Collateral Agent's Security Interest in the IP Collateral.


3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release.


