THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated May 8, 2020 by BMO Harris Bank N.A., a national banking association, with its mailing address at 111 W. Monroe Street, Chicago, Illinois 60606 (“*Secured Party*”).

WITNESSETH:

WHEREAS, Ryze Claim Solutions LLC, an Indiana limited liability company (“*Debtor*”), with its mailing address at 14701 Cumberland Road, Suite 300, Noblesville, Indiana 46060, and Secured Party were parties to a certain Trademark Collateral Agreement dated March 20, 2018 between Debtor and Secured Party which was recorded in the United States Patent and Trademark Office on March 21, 2018 at Reel 6296, Frame 0718 (the “*Agreement*”), pursuant to which Debtor granted to Secured Party, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”); and
