**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of July 1, 2020 by **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 275 Grove Street, Suite 2-200, Newton, Massachusetts 02466 (the “**Bank**”), in favor of **WORTHY, INC.**, a company organized under the laws of the State of Delaware, with its principal place of business at 30 Tuval St., Ramat-Gan, Israel, 5252242 (“**Grantor**”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of September 19, 2019 (as may be amended, modified, restated, replaced, or supplemented from time to time, the “**Agreement**”), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the (i) Trademark and Trademark Applications (“**Trademarks**”), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on September 24, 2019, at Reel 6752, Frame 0486, and (ii) Copyright and Copyright Applications (“**Copyrights**”), notice of which was recorded with the United States Copyright Office (“**USCO**”) on October 17, 2019, Receipt Number 1-3R3ZP1Z.

**WHEREAS**, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks and Copyrights (as defined in the Agreement) as herein provided; and

**WHEREAS**, Grantor has requested that the Bank provide a document suitable for recording with the USPTO and USCO to evidence the release of the Bank’s security interests in and liens on the Trademarks and Copyrights as herein provided.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in Grantor’s right, title and interest in, to and under the Trademarks and Copyrights, and all goodwill associated therewith, including, without limitation, those Trademarks and Copyrights identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO and USCO.
