IP SUPPLEMENT

This IP SUPPLEMENT, dated April 06, 2020, is delivered pursuant to and supplements (i) the Fourth Amended and Restated Security Agreement, dated as of June 26, 2018 (as it may be from time to time amended, restated, modified or supplemented, the "Security Agreement"), among The Wine Group, Inc., a California corporation ("TWG Inc."), The Wine Group LLC, a Delaware limited liability company (the "Company", and together with TWG Inc., the "Co-Issuers"), The Wine Group LLC ("Grantor"), the other Grantors named therein, and Coöperatieve Rabobank U.A., a Netherlands cooperative with excluded liability, New York Branch ("Rabobank"), as Collateral Agent, and (ii) the Grant of Trademark Security Interest dated as of June 26, 2018 (the "Grant") executed by Grantor. 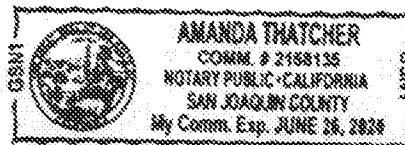
