INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment (this “Assignment”) dated as of December 21, 2018 (the “Effective Date”), is by and among (a) Open Road Films, LLC, a Delaware limited liability company, Open Road Releasing, LLC, a Delaware limited liability company, OR Productions, LLC, a Delaware limited liability company, Briarcliff LLC, a Delaware limited liability company, Open Road International LLC, a Delaware limited liability company, Empire Productions LLC, a Delaware limited liability company (the parties in this clause (a), each, an “Assignor” and, collectively, the “Assignors”), and (b) OR Acquisition Co, LLC, a Delaware limited liability company (“Buyer”). Capitalized terms used herein but not otherwise defined shall have the meanings set forth in that certain Asset Purchase Agreement, dated as of October 23, 2018 (as may be amended from time to time, the “Purchase Agreement”), by and among Buyer and the Seller Parties.

WHEREAS, under the terms of the Purchase Agreement, Assignors have conveyed, transferred, and assigned to Assignee or one or more of its applicable designees, among other assets, certain intellectual property of Assignors, and have agreed to execute and deliver this Assignment, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any other applicable jurisdictions.

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each Assignor hereby assigns and transfers to Assignee, absolutely and forever, all of its right, title, and interest, whether statutory or at common law, in and to, respectively, all of its rights, title, and interests pertaining to the Purchased Intellectual Property and the Title Rights (but excluding any right, title, or interest in the Excluded Intellectual Property), including (i) all trademarks, including registered and unregistered trademarks and applications to register any trademarks set forth in Schedule 1 hereto; and (ii) all right to police, monitor and enforce any of the foregoing against any past, current or future infringement which may have occurred (collectively, the “Assigned IP”).

2. Terms of the Purchase Agreement. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Assignors and Assignee with respect to the Assigned IP. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

3. Governing Law. THIS AGREEMENT IS TO BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH FEDERAL BANKRUPTCY LAW, TO THE EXTENT APPLICABLE, AND WHERE STATE LAW IS IMPLICATED, THE LAWS OF THE STATE OF DELAWARE SHALL GOVERN, WITHOUT GIVING EFFECT TO THE CHOICE OF LAW PRINCIPLES THEREOF, INCLUDING ALL MATTERS OF CONSTRUCTION, VALIDITY AND PERFORMANCE.


4. Counterparts. This Agreement may be executed in two or more counterparts (including by means of PDF or other electronic transmission), each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.
