This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 30, 2020, is made by PRIMO WATER OPERATIONS LLC (formerly PRIMO WATER OPERATIONS, INC.), a Delaware limited liability company with an address of 101 North Cherry Street, Suite 501, Winston-Salem, North Carolina 27101 (the "Secured Party"), in favor of Next Gen Ice, Inc., a Delaware corporation with an address of 1715 N. Rosemont, Suite 200, Mesa, Arizona 85205 (the "Grantor").

WHEREAS, pursuant to and subject to the terms of that certain Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") dated as of June 28, 2019, by and between the Grantor and the Secured Party, the Grantor granted to the Secured Party a continuing security interest in, and a continuing lien upon, all of the trademarks and trademark applications described on Exhibit A hereto (the "Trademarks"); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to the Secured Party that certain Notice of Security Interest in Trademarks evidencing Grantor's grant of a continuing security interest in, and continuing lien upon, the Trademarks, which was recorded at the United States Patent and Trademark Office on September 4, 2019 at Reel 6736 Frame 0455 (the "Notice").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party, without representation, warranty, or recourse, hereby terminates, cancels, discharges, and releases its continuing security interest in and continuing lien upon any and all right, title and interest of Grantor in and to the Trademarks that was granted pursuant to the Security Agreement or the Notice.
