**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
OF
SANTA ROSA SYSTEMS, LLC**

Pursuant to the provisions of KRS 14A and KRS Chapter 275, Santa Rosa Systems, LLC, a Kentucky limited liability company (the "Company"), hereby amends the Articles of Organization as set out below:

1. The name of the limited liability company is Santa Rosa Systems, LLC.
