## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated July 1, 2020 by FIFTH THIRD BANK, NATIONAL ASSOCIATION, formerly known as an Ohio banking corporation ("*Fifth Third*"), with its mailing address at 38 Fountain Square Plaza, Cincinnati, Ohio 45263, acting as administrative agent hereunder for the Secured Creditors as defined in the Agreement referred to below (Fifth Third acting as such administrative agent being hereinafter referred to as the "*Administrative Agent*");

### WITNESSETH:

The Administrative Agent hereby releases its security interests in, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:


