## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated July 1, 2020 by FIFTH THIRD BANK, NATIONAL ASSOCIATION, formerly known as an Ohio banking corporation ("*Fifth Third*"), with its mailing address at 38 Fountain Square Plaza, Cincinnati, Ohio 45263, acting as administrative agent hereunder for the Secured Creditors as defined in the Agreement referred to below (Fifth Third acting as such administrative agent being hereinafter referred to as the "*Administrative Agent*");

### WITNESSETH:

WHEREAS, RADIO SYSTEMS CORPORATION, a Delaware corporation (the "*Debtor*"), with its principal place of business and mailing address at 10427 PetSafe Way, Knoxville, Tennessee 37932, and the Administrative Agent were parties to a certain Trademark Collateral Agreement dated May 2, 2017 between the Debtor and the Administrative Agent which was recorded in the United States Patent and Trademark Office on May 5, 2017 at Reel 6050, Frame 0770 (the "*Agreement*"), pursuant to which the Debtor granted to the Administrative Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, the Debtor has requested that the Administrative Agent release its security interests in the Trademark Property;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Administrative Agent hereby releases its security interests in, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:


