Pursuant to Title 8, Section 264 of the Delaware General Corporation Law, Holley Performance Products Inc., a Delaware corporation, has executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Holley Performance Products Inc., a Delaware corporation (the "Company"), and the name of the limited liability company being merged (the "Merger") with and into the Company is Diablosport, LLC, a Delaware limited liability company ("Subsidiary").

SECOND: The Agreement and Plan of Merger dated as of November 14, 2019 by and between the Company and Subsidiary (the "Agreement of Merger") has been approved, adopted, certified, executed and acknowledged by each of the Company and the Subsidiary pursuant to Title 8, Section 264 of the Delaware General Corporation Law.
