TRADEMARK ASSIGNMENT AGREEMENT

Assignor hereby irrevocably assigns, conveys, transfers and delivers to Assignee, and Assignee hereby accepts, all of Assignor's entire, right, title and interest in and to the Assigned Trademark, and the portion of the business to which the mark pertains, together with all common law rights thereto and the goodwill of the business symbolized by, appertaining thereto, and associated with the Assigned Trademark.


This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
