## TRADEMARK ASSIGNMENT AGREEMENT

This Agreement is effective as of June 18, 2020 between China Manufacturers Alliance, LLC ("CMA"), a California limited liability company having a principal place of business at 406 East Huntington Drive, Suite 200, Monrovia, California 91016, USA, and Tianjin United Tire and Rubber International Co., Ltd., a corporation of the People's Republic of China having a principal place of business at Harbor Economic Area, Binhai New Area, 347 Hanjiang Road, Tianjin CHINA 300452 ("TUTRIC").

WHEREAS, CMA owns United States Trademark Registration Application Serial No. 88/660,076 for the trademark TIANLI (the "Registration Application"); and

WHEREAS, TUTRIC desires to acquire and CMA is willing to assign to TUTRIC all rights, title and interest in and to the TIANLI mark, the Registration Application, and any other rights CMA may have in the trademark TIANLI, the Registration Application and the Registration issuing thereon;

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

(1) CMA hereby assigns to TUTRIC all of its rights, title, and interest in and to the TIANLI mark, the Registration Application and any registration issuing thereon, including:


- a) all statutory and common law rights attaching to the Registration Application and registration issuing thereon and the TIANLI mark, including any and all goodwill associated with the TIANLI mark.
- b) the right to bring, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement (including all past infringements), or any other cause of action (including passing off) arising from ownership of any of the Registration Applicant and the TIANLI mark and any registration issuing thereon whether occurring before, on or after the date of this Agreement.


(2) This Agreement shall be governed and construed in accordance with the laws of the State of California (without regard to conflict of law principles).
