**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 2, 2020 ("Release"), is made by FIDUS INVESTMENT CORPORATION, a Maryland corporation, as collateral agent ("Collateral Agent") in favor of MIZUNI, INC., a Texas corporation ("Pledgor").

WHEREAS, pursuant to that certain Grant of Security Interest in Trademarks, by and between Collateral Agent and Pledgor (the "Trademark Security Agreement"), which was recorded at the United States Patent and Trademark Office ("USPTO") on June 11, 2019 at Reel 6666 and Frame 0630 ("Notice"), Pledgor granted to Collateral Agent a security interest in any and all of Pledgor's right, title, and interest in and to certain intellectual property, including the Trademarks listed on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

SECTION 2. Termination and Release. Collateral Agent, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of its right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, granted pursuant to the Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor's expense.
